## MINISTERIAL DETERMINATION ON THE FIXED PRICE FOR THE 2500 MHz TO 2570 MHz PAIRED WITH 2620 MHz TO 2690 MHz, AND 2575 MHz TO 2615 MHz FREQUENCY BANDS

#### **DETERMINATION NO.17 OF 2021**

IN exercise of the powers conferred by section 10 of the Communications and Multimedia Act 1998 [Act 588] ("Act"), the Minister makes the following determination:

#### **Citation and Commencement**

- 1. This determination may be cited as the Ministerial Determination on the Fixed Price for the 2500 MHz to 2570 MHz paired with 2620 MHz to 2690 MHz, and 2575 MHz to 2615 MHz Frequency Bands, Ministerial Determination No.17 of 2021.
- 2. This Determination shall come into operation on the date of its registration.

### Interpretation

3. Any terms used in this Determination shall, unless the context otherwise requires, have the same meaning as in the Act or the relevant subsidiary legislations made under it.

### **Fixed Price**

- 4. The Ministerial Determination on the Spectrum Reallocation for the 2500 MHz to 2570 MHz paired with 2620 MHz to 2690 MHz, and 2575 MHz to 2615 MHz Frequency Bands, Ministerial Determination No. 13 of 2021 has determined the following frequency bands be reallocated for spectrum assignments:
  - (a) 2500 MHz to 2570 MHz paired with 2620 MHz to 2690 MHz; and
  - (b) 2575 MHz to 2615 MHz.
- 5. The fixed price determined for the spectrum assignments of the reallocated frequency bands in paragraph 4 above shall be as follows:

Frequency Bands	Price Per 2x10 MHz or 20 MHz Spectrum Block
2500 MHz to 2570 MHz paired with 2620 MHz to 2690 MHz	Ringgit Malaysia Eleven Million Seven Hundred and Sixty Thousand only (RM11,760,000.00), shall be paid in lump sum
2575 MHz to 2615 MHz	Ringgit Malaysia Seven Million and Sixty Thousand only (RM7,060,000.00), shall be paid in lump sum

- 6. The fixed price for the spectrum assignments referred to in paragraph 5 above shall be applicable throughout the validity period of the said spectrum assignments.
- 7. The Minister may at any time modify, vary or revoke this Determination.
