MINISTERIAL DIRECTION TO DETERMINE A MANDATORY STANDARD ON ACCESS PRICING

DIRECTION No. 1 of 2003

In exercise of the powers conferred by sections 7 and 104(3) of the Communications and Multimedia Act 1998 [Act 588], the Minister issues the following Direction to the Commission:

Citation and commencement

This Direction may be cited as the Ministerial Direction to Determine a
Mandatory Standard on Access Pricing, Direction No. 1 of 2003 and shall come
into operation on the date of registration of this Direction.

Interpretation

2. Any term used in this Direction shall, unless the context otherwise requires, have the same meaning as in the Act or the Regulations made under it.

Mandatory Standard on Access Pricing

- 3. The Commission shall determine a Mandatory Standard on Access Pricing for some of the services that are listed in the Commission Determination on Access List, Determination No. 1 of 2001. The said prices shall be in the form of 24 hour weighted average price and will be fixed for the years 2003 to 2005.
- 4. The Mandatory Standard on Access Pricing shall cover the following services with the following maximum prices:

(a) Fixed Network Origination Service

Services	24 hour weighted average price in sen per minute
Local call origination	2.60
Local origination	2.00
Single tandem origination	4.80
Double tandem origination	8.43
Double tandem origination with submarine	19.70

(b) Fixed Network Termination Service

Services	24 hour weighted average price in sen per minute
Local call termination	2.60
Local termination	2.00
Single tandem termination	4.80
Double tandem termination	8.43
Double tandem termination with submarine	19.70

(c) Mobile Network Origination Service

Services	24 hour weighted average price in sen per minute
Fixed to Mobile/Mobile to Mobile (local)	11.26
Fixed to Mobile/Mobile to Mobile (long distance)	14.47
Fixed to Mobile/Mobile to Mobile (long distance with submarine)	22.52

(d) Mobile Network Termination Service

Services	average price in sen
Fixed to Mobile/Mobile to Mobile (local)	11.26
Fixed to Mobile/Mobile to Mobile (long distance)	14.47
Fixed to Mobile/Mobile to Mobile (long distance with submarine)	22.52

- 5. The matters which the Commission may address in the Mandatory Standard on Access Pricing are not limited to matters referred in paragraph 3 above.
- 6. The Minister may at any time modify, vary or revoke this direction.
