# COMMISSION DIRECTION TO NATSEVEN TV SDN. BHD. TO COMPLY WITH SPECIAL LICENCE CONDITIONS OF LICENCE NO. CASP/I/2000/2 ("the Licence")

#### **DIRECTION NO. 1 OF 2004**

IN exercise of the powers conferred by section 51 of the Communications and Multimedia Act 1998 [*Act 588*], the Commission issues the following Direction to Natseven TV Sdn. Bhd.:

#### Citations and commencement

1. This Direction may be cited as the Commission Direction to Natseven TV Sdn. Bhd. to comply with special licence conditions of Licence No. CASP/I/2000/2, Direction No. 1 of 2004 and shall come into operation on 25 October 2004.

#### Interpretation

2. Any term used in this Direction shall, unless the context otherwise requires, have the same meaning as in the Act or the regulations made under it.

#### **Compliance with Special Licence Condition**

- 3. Natseven TV Sdn. Bhd. is directed to :
  - (a) comply with special licence condition 11 of the Licence which states as follows:

## "11. NEWS TRANSMISSION

- 11.1 The Licensee shall provide news in Bahasa Melayu, which is produced by the Licensee for a duration of not less than THIRTY (30) minutes at 8.00 p.m. every day.";
- (b) cease broadcasting Edisi Siasat (Bahasa Melayu) (now known as "MySiasat" (Bahasa Melayu) in your 8.00 8.30 p.m. programming slot during weekends;
- (c) ensure that the news to be shown in compliance with special licence condition 11 of the Licence will report on recent and current happenings, domestically and internationally, particularly those which took place within 24 hours before transmission;
- (d) comply with special licence condition 14 of the Licence which states as follows:

## "14. CENSORSHIP OF CONTENT

- 14.1 All content to be transmitted by the Licensee shall be subject to the Film (Censorship) Act 1952 and regulations made thereunder including any statutory revisions or re-enactments made after the effective date of this licence.
- 14.2 The Licensee shall ensure that all content is censored and approved by the Film Censorship Board (Lembaga Penapisan Filem) before its transmission, as required under the law."; and
- (e) ensure that the following programmes are approved by the Film Censorship Board prior to transmission:
  - (i) 7 Di Pihak Anda;

- (ii) Edisi Siasat (Bahasa Melayu) (now known as "MySiasat" (Bahasa Melayu)); and
- (iii) Edisi Siasat (Bahasa Mandarin) (now known as "MySiasat" (Bahasa Mandarin).
