PERATURAN-PERATURAN KOMUNIKASI DAN MULTIMEDIA (PELESENAN)
(PINDAAN) 2025

PADA menjalankan kuasa yang diberikan oleh seksyen 16 Akta Komunikasi dan Multimedia 1998 [*Akta 588*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Komunikasi dan Multimedia (Pelesenan) (Pindaan) 2025**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 15 April 2025.

Pindaan peraturan 11

2. Peraturan-Peraturan Komunikasi dan Multimedia (Pelesenan) 2000 [*P.U. (A) 129/2000*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam subperaturan 11(1) dengan menggantikan perkataan “sepuluh tahun” dengan perkataan “sekurang-kurangnya lima tahun dan tidak lebih daripada sepuluh tahun”.

Pindaan peraturan 33

3. Peraturan 33 Peraturan-Peraturan ibu dipinda—

(a) dengan menggantikan perenggan 3(a) dengan perenggan yang berikut:

“(a) apabila permohonan diluluskan, sejumlah satu ratus ribu ringgit didarab dengan bilangan tahun bagi tempoh lesen yang diluluskan, hendaklah dibayar terlebih dahulu sebagai bayaran permulaan fi lesen tahunan yang terpakai; dan”;

(b) dengan memasukkan selepas subperaturan (3) subperaturan yang berikut:

“(3A) Bayaran permulaan fi lesen tahunan yang terpakai yang telah dibayar mengikut perenggan 3(a) tidak boleh dibayar balik dalam apa-apa hal keadaan, kecuali dalam hal jika lesen individu itu diserahkan mengikut Akta ini.”.

Pindaan Jadual Ketiga

4. Jadual Ketiga kepada Peraturan-Peraturan ibu dipinda dalam Borang A dengan memasukkan selepas butiran 2 butiran yang berikut:

“3. Tempoh lesen yang dimohon tahun/years”.
Period of licence applied

Kecualian

5. (1) Apa-apa permohonan lesen individu atau pembaharuan lesen individu yang dibuat di bawah Peraturan-Peraturan ibu yang belum selesai sebaik sebelum Peraturan-Peraturan ini mula berkuat kuasa hendaklah diuruskan di bawah Peraturan-Peraturan ibu seolah-olah Peraturan-Peraturan ibu tidak dipinda oleh Peraturan-Peraturan ini.

(2) Apa-apa lesen individu yang telah dikeluarkan di bawah Peraturan-Peraturan ibu sebelum tarikh permulaan kuat kuasa Peraturan-Peraturan ini hendaklah terus sah sehingga habis tempoh lesen individu itu atau pembatalan lesen individu itu seolah-olah Peraturan-Peraturan ibu tidak dipinda oleh Peraturan-Peraturan ini.

COMMUNICATIONS AND MULTIMEDIA ACT 1998

COMMUNICATIONS AND MULTIMEDIA (LICENSING) (AMENDMENT)
REGULATIONS 2025

IN exercise of the powers conferred by section 16 of the Communications and Multimedia Act 1998 [*Act 588*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Communications and Multimedia (Licensing) (Amendment) Regulations 2025**.

(2) These Regulations come into operation on 15 April 2025.

Amendment of regulation 11

2. The Communications and Multimedia (Licensing) Regulations 2000 [*P.U. (A) 129/2000*], which are referred to as the “principal Regulations” in these Regulations, are amended in subregulation 11(1) by substituting for the words “ten years” the words “at least five years and shall not be more than ten years”.

Amendment of regulation 33

3. Regulation 33 of the principal Regulations is amended—

(a) by substituting for paragraph 3(a) the following paragraph:

“(a) upon approval of the application, a sum of one hundred thousand ringgit multiplied by the number of years of the approved period of the licence, shall be paid in advance as initial payment of the applicable annual licence fee; and”;

(b) by inserting after subregulation (3) the following subregulation:

“(3A) The initial payment of the applicable annual licence fee that has been paid in accordance with paragraph 3(a) shall not be refundable

under any circumstances, except in cases where the individual licence is surrendered in accordance with the Act.”.

Amendment of Third Schedule

4. The Third Schedule to the principal Regulations is amended in Form A by inserting after item 2 the following item:

“3. Tempoh lesen yang dimohon tahun/years”
Period of licence applied

Saving

5. (1) Any application for an individual licence or renewal of individual licence made under the principal Regulations which is pending immediately before the coming into operation of these Regulations shall be dealt with under the principal Regulations as if the principle Regulations had not been amended by these Regulations.

(2) Any individual licence which has been issued under the principal Regulations before the date of coming into operation of these Regulations shall remain valid until the expiry of the individual licence or the revocation of the individual licence as if the principle Regulations had not been amended by these Regulations.
