COMMUNICATIONS AND MULTIMEDIA ACT 1998

MINISTERIAL DETERMINATION ON THE ISSUANCE OF SPECIFIED SPECTRUM ASSIGNMENT TO PARTICULAR PERSONS FOR THE 1800MHz SPECTRUM DETERMINATION NO. 7 OF 2016

IN exercise of the powers conferred by sections 10 and 174 of the Communications and Multimedia Act 1998 [Act 588] ("Act"), the Minister makes the following determination:

Citation and Commencement

- 1. This determination may be cited as the Ministerial Determination on the Issuance of Specified Spectrum Assignment to Particular Persons for the 1800MHz Spectrum, Determination No. 7 of 2016.
- 2. This Determination shall come into operation on the date of its registration.

Interpretation

3. Any terms used in this Determination shall, unless the context otherwise requires, have the same meaning as in the Act or the relevant subsidiary legislations made under it.

Specified Spectrum Assignment to Particular Persons

- 4. The Ministerial Determination on 1800MHz Spectrum Reallocation, Determination No. 5 of 2016 has determined the following frequency bands be reallocated for spectrum assignments:
 - (a) 1710MHz to 1785MHz; and
 - (b) 1805MHz to 1880MHz.

5. Pursuant to section 174 of the Act, the following persons have satisfied the conditions specified in the **Determination of Spectrum Assignment 2016** [*P.U. (B)* 365/2016] and shall be issued with the spectrum assignment as specified:

1.	Celcom Mobile Sdn Bhd (Company Registration No.: 27910-A)	1745MHz to 1765MHz (20MHz) paired with 1840MHz to 1860MHz (20MHz)
2.	Digi Telecommunications Sdn Bhd (Company Registration No.: 201283-M)	1765MHz to 1785MHz (20MHz) paired with 1860MHz to1880MHz (20MHz)
3.	Maxis Mobile Services Sdn Bhd (Company Registration No.: 73315-V)	1710MHz to 1730MHz (20MHz) paired with 1805MHz to1825MHz (20MHz)
4.	U Mobile Sdn Bhd (Company Registration No.: 223969-U)	1730MHz to 1745MHz (15MHz) paired with 1825MHz to1840MHz (15MHz)

- 6. The said spectrum assignments shall be effective on a date to be decided by the Commission, subject to the requirements under the Act and the relevant subsidiary legislations made under it.
- 7. The term of the spectrum assignments being made under this Determination shall be for 15 years from the effective date of the spectrum assignments.
