**COMMUNICATIONS AND MULTIMEDIA ACT 1998**  
**MINISTERIAL DETERMINATION ON FIXED PRICE FOR**  
**THE 1800MHz SPECTRUM BAND**

**MINISTERIAL DETERMINATION NO. 9 OF 2021**

IN exercise of the powers conferred by section 10 of the Communications and Multimedia Act 1998 [Act 588] ("Act"), the Minister makes the following determination:

**Citation and Commencement**

1. This determination may be cited as the **Ministerial Determination on Fixed Price for the 1800MHz Spectrum Band, Determination No. 9 of 2021**.
2. This Determination shall come into operation on the date of its registration.

**Interpretation**

3. Any terms used in this Determination shall, unless the context otherwise requires, have the same meaning as in the Act or the relevant subsidiary legislations made under it.

**Fixed Price**

4. The **Ministerial Determination on 1800MHz Spectrum Reallocation, Determination No. 5 of 2016** has determined the following frequency bands be reallocated for spectrum assignments:

- (a) 1710MHz to 1785MHz; and
- (b) 1805MHz to 1880MHz.

5. The fixed price for the spectrum assignments of the reallocated frequency bands referred to in paragraph 4 above has been determined through the **Ministerial Determination on Fixed Price for the 1800MHz Spectrum Band, Determination No. 10 of 2016** as follows:

PAYMENT METHOD	PRICE PER 2x5MHz SPECTRUM BLOCK
One Lump Sum Payment	Ringgit Malaysia Ninety Five Million and Eighty Five Thousand only (RM95,085,000.00)

PAYMENT METHOD	PRICE PER 2x5MHz SPECTRUM BLOCK
Five Equal Annual Payments	Ringgit Malaysia One Hundred Fourteen Million Nine Hundred and Sixty Thousand only (RM114,960,000.00)
Ten Equal Annual Payments	Ringgit Malaysia One Hundred Forty Four Million Eight Hundred and Fifty Five Thousand only (RM144,855,000.00)
Fifteen Equal Annual Payment	Ringgit Malaysia One Hundred Eighty Four Million and Twenty Thousand only (RM184,020,000.00)

6. Notwithstanding paragraph 5 above, any assignment holder that opts for a full settlement through a lump sum payment, after initially exercising the option to make equal annual payments in accordance with paragraph 5 above, shall be subject to a different fixed price based on the number of equal annual payments already made.

7. In view of paragraph 6 above, the new fixed price determined is as follows, which shall be payable within six (6) months from the date of issuance of this Determination:

PAYMENT METHOD	PRICE PER 2x5MHz SPECTRUM BLOCK
Lump Sum Payment	Ringgit Malaysia One Hundred Seventeen Million Three Hundred Sixty Thousand only (RM117,360,000.00)

8. The fixed price for the spectrum assignments referred to in paragraph 7 above shall be applicable throughout the validity period of the said spectrum assignments in respect of the assignment holders duly described in paragraph 6 above.
