## **COMMUNICATIONS AND MULTIMEDIA ACT 1998**

# MINISTERIAL DETERMINATION ON NOMINATED FACILITIES PROVIDER

DETERMINATION NO. 6 OF 2015

IN exercise of the powers conferred by sections 10 and 130 of the Communications and Multimedia Act 1998 [Act 588], the Minister makes the following determination:

#### Citation and commencement

- 1. This determination may be cited as the **Ministerial Determination on Nominated Facilities Provider**, Determination No. **61** of 2015.
- 2. This Determination shall come into operation on the date of its registration.

## Interpretation

- 3. For the purpose of this Determination, unless the context otherwise requires:
  - "Agreement" means the Nominated Facilities Provider appointment Agreement between Tenaga Nasional Berhad (200866-W) and Asian Broadcasting Network (M) Sdn. Bhd. (514935-T) dated 4 February 2015; and
  - "network facilities" mean the optical fibre cables and towers, poles, ducts and pits used in conjunction with other network facilities owned by Tenaga Nasional Berhad.
- 4. Any term used in this Determination shall, unless expressly defined or if the context otherwise requires, have the same meaning as that contained in the Act or the Regulations made under it.

# The network facilities subject to nomination

- 5. Pursuant to the Agreement, Tenaga Nasional Berhad has allowed Asian Broadcasting Network (M) Sdn. Bhd. the right to access and use of the network facilities.
- 6. These network facilities fall under the category of fixed links and cables and towers, poles, ducts and pits used in conjunction with other network facilities under the Communications and Multimedia (Licensing) Regulations 2000 [*P.U.(A)* 129/2000].
- 7. The location of the network facilities is specified in **Schedule 1**.
- 8. Asian Broadcasting Network (M) Sdn. Bhd. shall notify the Commission in writing not less than sixty (60) days on any changes to the network facilities subject to nomination, location of the network facilities or the extension of the duration of the Agreement before such changes or extension takes effect.

# The Nominated Facilities Provider for the purposes of this Act

9. Asian Broadcasting Network (M) Sdn. Bhd., a Network Facilities Provider Individual licensee No. NFP/I/2000/130 shall be the nominated facilities provider for the network facilities for the purposes of the Act.
