### **PUBLIC INQUIRY ON REVIEW OF COMMISSION DETERMINATION ON THE MANDATORY STANDARDS FOR THE PROVISION OF MOBILE CONTENT SERVICES DETERMINATION NO. 4 OF 2009**

**CYBERJAYA, 30 APRIL 2025** --- The Malaysian Communications and Multimedia Commission (MCMC) is holding a Public Inquiry commencing on 30 April 2025 until 16 June 2025, pursuant to Sections 55(2) to (9), 56, and 61 of the Communications and Multimedia Act (CMA) 1998.

The Public Inquiry is on the review of Commission Determination on Mandatory Standards for the provision of Mobile Content Services ("MSMCS") Determination No. 4 of 2009 and aims to gather views on the MSMCS.

MCMC invites industry players, stakeholders, and members of the public to participate in this Public Inquiry by submitting written feedback on the specific questions and preliminary views outlined in the Public Inquiry. Respondents are encouraged to support their submissions with justifications and, where applicable, provide relevant data or information.

### **SIASATAN AWAM MENGENAI KAJIAN SEMULA PENENTUAN SURUHANJAYA BERKENAAN STANDARD MANDATORI BAGI PERKHIDMATAN KANDUNGAN MUDAH ALIH PENENTUAN NO. 4 TAHUN 2009**

**CYBERJAYA, 30 APRIL 2025** --- Suruhanjaya Komunikasi dan Multimedia Malaysia (MCMC) akan mengadakan Siasatan Awam mulai 30 April 2025 hingga 16 Jun 2025, selaras dengan Seksyen 55(2) hingga (9), 56, dan 61 Akta Komunikasi dan Multimedia (AKM) 1998.

Siasatan Awam ini adalah mengenai kajian semula Penentuan Suruhanjaya berkenaan Standard Mandatori bagi Pekhidmatan Kandungan Mudah Alih ("*MSMCS*") Penentuan No. 4 bagi Tahun 2009 dan bertujuan untuk mendapatkan pandangan mengenai MSMCS.
