1	Regarding the training section, do they want to learn all software mentioned in the first row in 10 days? What topics they need to cover in the training session?	Hands-on training of all software, basic knowledge on how to use them. 10 days meaning it can be divided into 2 weeks.
2	What do they mean by installing 2 units of Burp Suite on Ubuntu? 2 units on the same os?	i. Two (2) copies of burp suites to be installed on two (2) virtual machines running Ubuntu.Those virtual machines running in 2 windows laptop, one each. ii. Another two copies to be installed in 2 Apple laptops, one each.
3	Do they want to implement a separate network for their penetration testing? Or will it be located in the existing network? In that case do they want to protect their network with a firewall?	Out of scope. All software are to be installed in respective laptops (2 apple & 2 windows). No network configuration needed.
4	If they want to get the certification in any of the mentioned training they have to follow the standard content. Is it possible for them to inform us that for which of the training sessions they want to get the original certifications?	Certification training is ONLY for IBM Security AppScan Standard for 2 pax . This is normally conducted in their training facility (licensed training provider). Therefore it is bound to its proprietary training syllabus.
5	What do they generally mean by quantity? Is it the number of license which they want? Or is it the number of installation of the software? For example for Nessus they need license for 1 user but the quantity is 4. What does it mean?	i. For Para 7 (and its subsidiaries) , it means quantity of licenses. For illustration: Nessus - 4 licenses (therefore 4 copies of software) ii. For Para 8 (and its subsidiaries) , it means number of installations.
