Existing Anti-Spam Agreements

Several now in place around the world:

- London Action Plan (LAP): around 40 signatories
- European region: EU Regional MoU
- Tri-lateral: UK / USA / AUS
- Bi-lateral: KISA-ACA
- Asian region: Seoul-Melbourne MoU: 12 agencies
- Other inter-agency MoUs also in place



Seoul-Melbourne MoU – history

- **KISA-ACA bilateral MoU: signed Oct 2003**
- **We cooperated on:**
 - mobile spam; compromised servers; educational + technical solutions
- **Then we planned to:**
 - adapt MoU document
 - expand to Asian region
- **Invitations sent: December 2004**
- **Founding signatories announced: April 2005**
 - 12 agencies from 10 countries / regions



Seoul-Melbourne MoU – focus

- **Asian region (but room to expand in future)**
- **Exchange information on:**
 - Legal and policy solutions
 - Technical solutions
 - Educational solutions
 - Industry collaboration
 - Intelligence and data
 - Spam trends
 - Network threats
 - Resources and role of each agency
- **Also allows for joint enforcement**



Defining features

- **Agency-to-agency focus (not state-to-state)**
- **Operational level (not high level)**
- **Regional focus:**
 - Tackle most relevant issues, e.g. compromised machines
 - Build networks across region
- **General: can join without spam laws**
- **Complement other MoUs**
 - Diff regions and scopes



Challenges

- **Many countries have no spam laws**
- **Spam laws and definitions differ**
- **Other laws differ (e.g. privacy)**
 - Challenge for joint enforcement
 - Challenge for information-sharing
- **Priorities and skill sets of agencies will vary**
- **As network grows, it gets more unwieldy**
- **Resources an issue**



Next steps under MoU

- **Exchange information**
 - Agencies' roles + resources ('Signatory Schedules')
- **Plan activities**
 - Input from signatories
 - Circulate and discuss by email
- **Set up first meeting**
 - Web conference
- **Undertake joint projects**
- **Make use of networks**
