BACKGROUND (1/2)

- Mobile Monitoring System (MMS) is a vehicular-based spectrum monitoring system.
- In 2013, MCMC procured 3 units of MMS equipped with spectrum monitoring system from Rohde & Schwarz

Existing MMS capabilities

- spectrum monitoring and DF up until 3GHz
- consist of antenna, receiver, processor & synthesizer and display & control
- For MMS-KCH and MMS-JBU, equipped with pneumatic mast – to raise DF and Yagi antennas

- Current location: MCMC
 Pahang State Office
- New location: MCMC
 Sarawak State Office

MMS-JBU (MERCEDES BENZ SPRINTER)

- Current location: MCMC Johor State Office
- New location: No relocation



BACKGROUND (2/2)



• 2 options available for participating Tenderer:

<u>Option 1:</u> Re-use existing equipment

- Re-use existing Rohde & Schwarz equipment from the 3 MMS.
- Install the existing equipment into new SUV.





- Supply new equipment with equivalent or better specifications than existing equipment.
- Install the new equipment into new SUV.
- Provide a comparison table to justify the specifications of new equipment against existing equipment.

SCOPE OF WORK | PRELIMINARY



PARAGRAPH 42: PRELIMINARY STAGE

- Propose and obtain approval from MCMC on the detailed project timeline to complete the work within project duration of 12 months or earlier;
- Perform on-site functionality and equipment assessments on the configuration and condition of existing systems*;
- Properly remove only required equipment installed inside the 3 MMS vehicles*;
- Securely station the MMS vehicles at the successful Tenderer's office prior to removal work*.

*Note: only applicable to Tenderer who will reuse existing equipment

Shall be carried out before tender submission to include repair cost. Request shall be made before 20 Nov via tender@mcmc.gov.my


- Design three (3) Sport Utility Vehicle (SUV) to house spectrum monitoring system;

- Present approved engineering system design and vehicle drawings to MCMC for approval;
- Ensure usage class for three (3) MMS are retained as individual usage class; and,
- All documents shall be approved by relevant parties and MCMC.










