MINISTERIAL DETERMINATION ON THE ISSUANCE OF SPECIFIED SPECTRUM ASSIGNMENT TO PARTICULAR PERSON FOR THE 880 MHz TO 885 MHz PAIRED WITH 925 MHz TO 930 MHz FREQUENCY BANDS

DETERMINATION NO. 14 OF 2021

IN exercise of the powers conferred by sections 10 and 174 of the Communications and Multimedia Act 1998 [Act 588] ("Act"), the Minister makes the following determination:

Citation and Commencement

- 1. This determination may be cited as the Ministerial Determination on the Issuance of Specified Spectrum Assignment to Particular Person for the 880 MHz to 885 MHz paired with 925 MHz to 930 MHz Frequency Bands, Ministerial Determination No. 14 of 2021.
- 2. This Determination shall come into operation on the date of its registration.

Interpretation

3. Any terms used in this Determination shall, unless the context otherwise requires, have the same meaning as in the Act or the relevant subsidiary legislations made under it.

Specified Spectrum Assignment to Particular Person

- 4. The Ministerial Determination on the Spectrum Reallocation for the 880 MHz to 885 MHz paired with 925 MHz to 930 MHz Frequency Bands, Ministerial Determination No. 12 of 2021 has determined the following frequency bands be reallocated for spectrum assignment:
 - (a) 880 MHz to 885 MHz; and
 - (b) 925 MHz to 930 MHz.

- 5. Pursuant to section 174 of the Act, Altel Communications Sdn Bhd (Company Registration No.: 201201010379) has satisfied the conditions specified in the **Determination of Spectrum Assignment under Sections 10 and 174** [P.U. (B) 337/2021], and shall be issued with the spectrum assignment in the 880 MHz to 885 MHz paired with 925 MHz to 930 MHz frequency bands.
- 6. The said spectrum assignment shall be effective on a date to be decided by the Commission, subject to the requirements under the Act and the relevant subsidiary legislations made under it.
- 7. The term of the spectrum assignment being made pursuant to this Determination shall be for five (5) years from the effective date of the spectrum assignment.
- 8. The Minister may at any time modify, vary or revoke this Determination.
