MINISTERIAL DETERMINATION ON THE ISSUANCE OF SPECIFIED SPECTRUM ASSIGNMENTS TO PARTICULAR PERSONS FOR THE 2500 MHz TO 2570 MHz PAIRED WITH 2620 MHz TO 2690 MHz, AND 2575 MHz TO 2615 MHz FREQUENCY BANDS

DETERMINATION NO.16 OF 2021

IN exercise of the powers conferred by sections 10 and 174 of the Communications and Multimedia Act 1998 [Act 588] ("Act"), the Minister makes the following determination:

Citation and Commencement

1. This determination may be cited as the **Ministerial Determination on the Issuance of Specified Spectrum Assignments to Particular Persons for the 2500 MHz to 2570 MHz paired with 2620 MHz to 2690 MHz, and 2575 MHz to 2615 MHz Frequency Bands, Ministerial Determination No. 16 of 2021.**
2. This Determination shall come into operation on the date of its registration.

Interpretation

3. Any terms used in this Determination shall, unless the context otherwise requires, have the same meaning as in the Act or the relevant subsidiary legislations made under it.

Specified Spectrum Assignments to Particular Persons

4. The **Ministerial Determination on the Spectrum Reallocation for the 2500 MHz to 2570 MHz paired with 2620 MHz to 2690 MHz, and 2575 MHz to 2615 MHz Frequency Bands, Ministerial Determination No. 13 of 2021** has determined the following frequency bands be reallocated for spectrum assignments:
 - (a) 2500 MHz to 2570 MHz paired with 2620 MHz to 2690 MHz; and
 - (b) 2575 MHz to 2615 MHz.

5. Pursuant to section 174 of the Act, the following persons have satisfied the conditions specified in the **Determination of Spectrum Assignment under Sections 10 and 174 [P.U. (B) 337/2021]**, and shall be issued with the spectrum assignments as specified:

6. The said spectrum assignments shall be effective on a date to be decided by the Commission, subject to the requirements under the Act and the relevant subsidiary legislations made under it.

7. The term of the spectrum assignments being made pursuant to this Determination shall be for five (5) years from the effective date of the spectrum assignments.

8. The Minister may at any time modify, vary or revoke this Determination.
