# **COMMUNICATIONS AND MULTIMEDIA ACT 1998**

# VARIATION TO THE MINISTERIAL DIRECTION ON INTERWORKING WITH OTHER AUTHORITIES (DIRECTION NO. 4 OF 2001)

## **MINISTERIAL DIRECTION NO.1 OF 2022**

In exercise of the powers conferred by sections 7, 8 and 269 of the Communications and Multimedia Act 1998 [*Act 588*] ("**Act**"), the Minister issues the following direction to the Commission:

#### Citation and Commencement

1. This direction may be cited as the Variation to the Ministerial Direction on Interworking with Other Authorities (Direction No. 4 of 2001), Direction No. 1 of 2022 and shall come into operation on the date of the registration of this instrument.

# Interpretation

2. Any terms used in this Direction shall, unless the context otherwise requires, have the same meaning as in the Act or the subsidiary legislations made under it.

## Variation to Schedule A

3. The Ministerial Direction on Interworking with Other Authorities, Direction No. 4 of 2001 ("**principal Direction**") is varied by substituting Schedule A with the following Schedule:

xi. networked content regulation; and

xii. collaboration, coordination and partnerships.

The interworking with such authorities or international organisations shall be notified to the Minister in writing prior to the interworking.

## **Other Provisions**

4. Save for the variations expressly provided in this Direction, all other provisions as contained in the principal Direction shall remain unchanged and continue to be in full force and effect.
