# VARIATION TO THE COMMISSION DIRECTION ON PUBLIC CELLULAR BLOCKING SERVICE FOR CELLULAR MOBILE ACCESS DEVICES UNDER REQUIRED APPLICATIONS SERVICES (DIRECTION NO. 1 OF 2013)

#### Direction No. 2 of 2017

In exercise of the powers conferred by sections 52, 193(2) and 194 of the Communications and Multimedia Act 1998 [Act 588], the Commission issues the following direction:

#### Citation and Commencement

- 1. This direction may be cited as the Variation to the Commission Direction on Public Cellular Blocking Service for Cellular Mobile Access Devices under Required Applications Services (Direction No. 1 of 2013), Direction No. 2 of 2017.
- 2. This Direction shall come into operation on the date of its registration.

#### Variation to paragraph 28

3. The Commission Direction on Public Cellular Blocking Service for Cellular Mobile Access Devices under Required Applications Services, Direction No. 1 of 2013 ("principal Direction") is varied in paragraph 28 by deleting the words "*monthly in advance*".

#### Variation to paragraph 29

- 4. Paragraph 29 of the principal Direction is varied by substituting the said paragraph with the following paragraph:
  - "29. The PCBS Service Fee shall be calculated based on monthly pro-rated fee based on the number of active subscribers for a particular month. Payment shall be made on a quarterly basis, whereby for a particular quarter, the payment of the three (3) months in the said quarter shall be made in the following month after the last month in the said quarter."

### For example:

Month	Subscribers	Monthly PCBS Fee
July	10.0mil	(RM0.50/12) x 10.0mil = RM416,666
August	10.2mil	(RM0.50/12) x 10.2mil = RM425,000
September	10.4mil	(RM0.50/12) x 10.4mil = RM433,333
	Total Quarter 3	RM1,274,999

## Variation to paragraph 30

- 5. Paragraph 30 of the principal Direction is varied by substituting the said paragraph with the following paragraph:
  - "30. The payment of the PCBS Service Fee shall be made by the relevant applications service providers to the Commission within thirty (30) days from the receipt of the written notice or notification issued by the Commission in respect of such payment."

### Variation to paragraph 31

6. Paragraph 31 of the principal Direction is varied by inserting after the words "written notices" with the words "or notification".

Other provisions under the principal Direction and the Variation to the Commission Direction on Public Cellular Blocking Service for Cellular Mobile Access Devices under Required Applications Services (Direction No. 1 of 2013), Direction No. 1 of 2017

7. Save for the variation expressly provided in this Direction, all other provisions as contained in the principal Direction and the Variation to the Commission Direction on Public Cellular Blocking Service for Cellular Mobile Access Devices under Required Applications Services (Direction No. 1 of 2013), Direction No. 1 of 2017 shall remain unchanged and continue to be in full force and effect.
